

## Privacy information notice - CDP Newsletter and events

Information pursuant to articles 13 and 14 of the European Regulation 2016/679 (GDPR)

### **Data Controller**

Pursuant to European Regulation 2016/679 (hereinafter GDPR), Cassa Depositi e Prestiti S.p.A. (hereinafter CDP), with its registered office in Rome, via Goito n. 4 (00185), processes your personal data as the "Data Controller" in accordance with the provisions of the law and informs you about the use of such personal data. ### Purpose of processing

Your data will be processed for the sole purpose of preparing and operating the requested service and/or the organisation of a specific event organised by CDP, including online events. The data are provided by the Data Subject in relation to the purposes pursued. The data will not be communicated or disclosed to other parties - except for any suppliers acting as independent controllers or external processors - and will be processed for the sole purpose of providing the requested service.

### Data processing method

In relation to the purposes specified, the personal data are processed by means of manual, IT and telematic instruments using logic appropriate for the purposes and, in any case, in order to guarantee the security and confidentiality of said data. Protection is also ensured in the presence of innovative instruments introduced by CDP.

#### Storage of personal data

Your personal data will only be stored for the time necessary for the purposes for which they are collected in accordance with the principle of minimisation pursuant to art. 5.1.c) GDPR.

# Rights of the Data Subject

You are informed that art. 15-22 GDPR entitle the Data Subjects to exercise specific rights; the Data Subject can obtain from CDP: access, rectification, erasure, restriction of processing, withdrawal of consent, and portability of the data concerning him/her.

The Data Subject also has the right to object to processing. In the event of the right of objection being exercised, CDP reserves the right to not follow up the request, and therefore continue the processing, if there are binding legal grounds for proceeding with the processing overriding the interests, rights and freedoms of the Data Subject. point 1. The Data Subject also has the right to raise complaints with the Italian Data Protection Authority.
