A.2 Description of research projects

For each research project, produce a project information sheet that briefly describes the aims of the research, the methodology to be used and the expected impact. You do not need to complete a budget sheet at this stage. The bibliography is not included in the page count and should be added at the foot of the document. You may not insert external links, which in any event will not be considered for the purposes of evaluation

A.1 The research initiative

A.1.1 Description of the challenges that the project is intended to tackle in the selected field [max 3 pages, font size 11, spacing 1]

This section must focus primarily on the areas of excellence and innovation that the research project (theoretical and applied) aims to tackle. The bibliography is not included in the page count and should be added at the foot of the document. You may not insert external links, which in any event will not be considered for the purposes of evaluation.

A.1.2 Full description of research projects

Each research project must contain the following sections: state of the art, aims, methodology, feasibility, risk management, short- and medium-term impact and effects on the coverage area. You also need to provide a Gantt chart and a breakdown of the activities by work package. The bibliography is not included in the page count and should be added at the foot of the document. You may not insert external links.

A.4 Partnership agreement [max 5 pages, font size 11, spacing 1]

The agreement document must be signed by the legal representative of each of the partners involved. It must contain the following sections: aims of the collaboration; duration of the agreement, roles and responsibilities of the Parties; use of resources and economic share of the partners involved in the partnership; procedures and tools for managing and generating value from the intellectual property rights covering the results of the proposed research.

The budget must be completed in the format provided (attached).
